**A RESOLUTION OF THE CITY OF ORTING, WASHINGTON,
DELEGATING CERTAIN CHANGE ORDER AUTHORITY TO
MAYOR AND/OR CITY ADMINISTRATOR**

WHEREAS, the City of Orting is a code city duly incorporated and operating under a Mayor-Council form of government under chapter 35A.12 RCW; and

WHEREAS, the City Council has plenary authority to authorize, amend, repeal, and revise contracts to which the City is a party; and

WHEREAS, the City Council authorized through AB25-106 the execution of a public works contract for roadway improvements on Kansas Street SW (Project No. 2025-08) on December 10, 2025, for a not to exceed amount of \$4,687,687.00; and

WHEREAS, the City Council further authorized through AB25-106 a contingency of \$468,768, representing 10 percent of the not to exceed amount; and

WHEREAS, the City Council recognizes that there must be added flexibility to respond to change order requests more quickly than the Council can reasonably meet under its regular schedule; and

WHEREAS, the City Council intends to preserve its authority to authorize, reject, and modify changes to Project 2025-08 outside the authorized contingency;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ORTING AS FOLLOWS:


Section 1. Recitals. The foregoing recitals are incorporated herein by this reference.

Section 2. Authorization and Delegation. The Mayor and/or City Administrator are authorized to execute any change order for Project 2025-08 (Kansas Street SW Reconstruction) PROVIDED that the change (1) is within the amount of authorized contingency as reduced by all prior change orders, (2) does not substantially and materially alter the scope of the project authorized by AB25-106. If any change would, in the aggregate of all other prior changes, result in the expenditure of funds beyond the previously authorized contingency, such change must be approved by Council in advance.

Section 3. Corrections. The City Clerk and the codifiers of this resolution are authorized to make necessary clerical corrections to this resolution including, but not limited to, the correction of scrivener's errors, references, numbering, section/subsection numbers and any references thereto.

Section 4. Effective date. This Resolution shall become effective immediately upon adoption and signature as provided by law.
